- Input into relevant areas of monthly, quarterly and annual financial information and associated reporting to Pilgrims US.
- Complete all reporting in line with established group and HMRC/Revenue timetables.
- Deliver key balance sheet account reconciliations which will feed into the overall entity reconciliations.
- Complete relevant areas in relation to periodic tax postings and statutory accounting.
- Work with other members of the finance team to ensure consistency of working across the business units and to ensure best practice is implemented and followed.
- Work on cross-functional projects where required providing expert guidance from a financial and tax viewpoint.
- Assistance with Senior Accounting Officer (SAO) administration.
- Assistance with Country-By-Country Reporting and Pillar 2 analysis.
- Assistance with Annual corporation tax computations and quarterly instalment payments.
- Operate with the highest standards of financial integrity, collaborative working and demonstrate each of the company values to a high level.
- Work as part of a highly motivated team, coaching and supporting other more junior members of the team.
